# 21ST ANNUAL NATP DRIVERS TRAINING & ROADEO



The Nebraska Association of Transportation Providers (NATP) held their Annual Statewide Roadeo and Drivers Training at the Nebraska Safety Center in Kearney on September 17 and 18. A total of twenty three drivers from across the state registered and competed in the

Roadeo. Thirty two volunteers, made up of transit managers and staff, NDOR staff and others stepped in to judge the event. Jeff Baker of Seward County Transit and Cindy Sanders of Guide Rock Public Transit were co-chairs for the Roadeo.

Everyone who participated in the Roadeo, either as a judge or a contestant, was invited to an awards luncheon. All Roadeo contestants were announced and presented with a certificate and a Roadeo lapel pin. Drivers who had been accident free for the past 12 months were awarded a Safe Driver Award window sticker to place in their vehicle. Roadeo Committee members were asked to stand and be thanked for their hard work in putting together this event.

Committee members include Jeff Baker, Scott Bartels, Wayne Masek, Cindy Sanders, Denise Smith, Corrina Duckworth and Neva Umstead. Judges were then announced and presented with a tire gauge which featured the NATP logo to thank them for their hard work. The event could not have taken place without the help of everyone.

The Roadeo competition consists of a written test, pre-trip inspection and wheelchair securement segments, and a driving skills course. This year, a new minivan category was added to go along with the van and small bus divisions already in place. There was also a Hawaiian theme this

## Public Information Meetings Nov. 5 to Discuss Transit Service Pilot Program

Transit agencies in Webster County, Franklin County, and Guide Rock, along with the Nebraska Department of Roads (NDOR) will hold public information meetings to discuss implementation of a pilot program for coordinating service to the regional center communities of Kearney, Grand Island and Hastings. The purpose of the meetings is to describe the service changes for the pilot program and take comments.

The meetings are in support of NDOR's mobility management project to increase cooperation and coordination among public transportation providers.

## FTA Drug & Alcohol Compliance

The Nebraska Department of Roads (NDOR) Rail and Public Transportation Division has secured the professional services of Precision Compliance Inc. (PCI), and FTA drug and alcohol compliance specialist. PCI will provide support, training, and technical assistance to all 5311 sub-recipients and the NDOR Transit Section to ensure compliance with the Federal regulations mandating drug and alcohol testing.

Over the next twelve months, PCI will schedule and conduct site visits at all 5311 transit systems. They will review current policies, procedures, and record-keeping practices. As identified deficiencies are corrected and to ensure continued compliance, PCI staff will provide ongoing technical assistance and support to your drug and alcohol program manager

PCI staff will also conduct training at 4 locations across the state in the spring of 2014. More details about training will be released as dates and venues are finalized. At least one representative from your organization should plan to attend one of the two-day trainings. Tentative training schedule:

# PONCA EXPRESS TRANSIT FACILITY

Construction is under way in Norfolk for a new Ponca Express transit facility. Ponca Express is a public transportation system administered by the Ponca Tribe of Nebraska. The \$3.5 million project is funded by the Federal Transit Administration and is expected to be completed by April 2014. The 15,000 square foot building will include space for 16 vehicles, 12 offices, conference rooms and a FEMA storm shelter.

Ponca Express is based in Norfolk with a satellite location at the Tribal Headquarters in Niobrara.

Ponca Express became of member of NATP in 2013.

The service area includes Winnebago, Columbus, Wayne, Lincoln, Omaha, Grand Island and Sioux Falls, South Dakota.

The public comment period for the required driver training project ended October 25, 2013. The comments will be compiled and shared with transit managers through a link on the NDOR Transit Section and NATP websites. NDOR will collaborate with the UNK Safety Center to develop a draft 12-18 month training schedule that will also be released for public comment prior to implementation of the program.

met recently with We representatives from the University, School of Public Administration, to discuss the Title VI compliance project for the rural transit systems. For those of you who attended the 2013 Transit Managers' Workshop, you will recall that Title VI was a topic discussed during the rural network session. Non-compliance with Title VI requirements was noted as a finding during NDOR's 2012 State Management Review and continues to be a concern for FTA Region VII.

Please continue to use the resources provided on our website posters, templates, (forms, samples, etc.). The University will create an FTA compliant Title VI template plan for your use which will also be posted on our website. In addition, we have tasked them with researching the census demographic data for each of the systems. information is critical to the Four Factor Analysis required for your limited English proficiency (LEP) plan. The LEP plan will be part of your overall Title VI plan and is often the most confusing and cumbersome element.

The kick-off date for the Title VI compliance project is tentatively scheduled for November 1, 2013. Our goal within the first 12 months is for every system to have a Title VI plan submitted to NDOR and approved. A minimum of four Title VI workshops will be

scheduled across the state in the spring/summer of 2014. You are strongly encouraged to send at least one representative from your transit system to a workshop in your area.

Thanks to those of you who have already spent a considerable amount of time and effort addressing Title VI compliance. I wanted you all to be aware that additional resources will be available very soon.

It has been brought to our attention on several occasions that there are only a small number of mechanics across the state trained to work on the Braun wheelchair lifts. This is causing a burden for the systems especially in the western part of the state. It is also a potential safety and asset management issue.

We are working with the Braun Corporation to bring training to Nebraska in the spring-summer 2014. The training will be scheduled at multiple locations across the state and offered at no cost to private sector mechanics and any driver/mechanics in the transit systems. After the training, NDOR will compile a list of trained mechanics that will be available on our website.

To facilitate this project, please provide the following information:

- 1. Name and contact information for the company currently providing wheelchair lift repair and routine maintenance for your transit agency.
- 2. Name and contact information for the mechanic/shop currently providing repair and routine maintenance for your vehicles (if different than above).

Per the regulations, your transit vehicles are defined as buses and buses and school buses are required to stop at all railroad grade crossings. Stickers for your vehicles are available through a number of internet suppliers. You can submit the cost with your operating assistance invoice.

. . . . . . . . . . . . . . . .

# 60-6,172. Buses and school buses required to stop at all railroad grade crossings; exceptions.

- (1) The driver of any bus carrying passengers for hire or of any school bus, before crossing at grade any track of a railroad, shall stop such vehicle within fifty feet but not less than fifteen feet from the nearest rail of such railroad and while so stopped shall listen and look in both directions along such track for any approaching train and for signals indicating the approach of a train, except as otherwise provided in the Nebraska Rules of the Road. The driver shall not proceed until he or she can do so safely. After stopping as required by this section and upon proceeding when it is safe to do so, the driver of any such vehicle shall cross only in such gear of the vehicle that there will be no necessity for changing gears while traversing such track and the driver shall not shift gears while crossing such track.
- (2) No stop shall be made at any such crossing when a peace officer or a flagperson directs traffic to proceed or at an abandoned or exempted grade crossing which is clearly marked as such by or with the consent of competent authority when such markings can be read from the driver's position.
