2018 NATP ROADEO

The Nebraska Association of Transportation Providers held its Annual Statewide Roadeo at the Nebraska Safety Center in Kearney on September 19. Drivers, volunteers and staff participated in the event. Jeff Baker of Seward County Public Transit and Cindy Sanders of Guide Rock Public Transit were once again co-chairs of the event.

Following the Roadeo competition, all attendees gathered for an awards luncheon. Drivers from both divisions were introduced and presented with certificates for their

The event could not have occurred without the planning of the Roadeo Committee members including Jeff Baker, Cindy Sanders, Scott Bartels, Denise Smith, Corrina Duckworth, Bill Bivin, Coletta Clouse, Wayne Masek, and Beth Siegfried. The Nebraska Safety Center donated the use of the driving range, garage and tent, and provided volunteers for the event.

The Roadeo competition consists of a written test, pretrip inspection, wheelchair securement, and a driving skills course. The theme was "Mardi Gras".

This year additional scholarships are available so first, second and third place drivers from each division and their managers are eligible to attend and compete in the CTAA National Roadeo in Palm Springs, California, in May 2019.

First place winners of both divisions took home a \$250 check and an engraved clock. The second-place winners received a \$150 check along with an engraved key ring. Third place winners were presented with a \$100 check.

Winners of the small bus division were Marvin Baden, Blue Rivers Area Agency of Aging, first place; Diane Schaepe, Seward County Transit, second place; and Carol Graham, Blue

Rivers Area Agency on Aging, third place.

Mini-van division winners included, first place, Mindy Manning, Florence Home; second place, Ramona Daniels of Saline County Area Transit; and third place, Rod Kinning, Avera Creighton Hospital.

The Driver of the Year Award went to Mindy Manning who had the highest score of the day. Mindy received a \$50 gift card as a prize and took home the traveling trophy for winning the mini-van division. *Continued on page 3...*

Greetings Transit Friends,

It has been an exciting and busy Fall. Several agencies received new vehicles, some of which were promptly recalled. NATP hosted its annual Roadeo along with continuing education core courses. A number of transit managers traveled to Breckenridge, CO for the TRB/RIBTC Conference. You will learn more about that event by reading the comments from attendees in this newsletter. And just last week Jennifer Eurek and I hosted the NATP booth at the Nebraska Association of County Officials (NACO).

Saline County Area Transit's 2018 Dodge was recalled for a brake issue that was quickly resolved at the dealership, almost in less time than it took us to travel there and back again. However, the BraunAbility recall on the 2014

and 2016 lowered floor models hasn't gone as smoothly. We are still trying to schedule an agreeable time to take them in. Unfortunately, our best options for service are to travel either to Omaha or Kansas City, two plus and three and a half hours one way, and Omaha can't get us scheduled for a couple of weeks. On September 19th, NATP hosted its 26th annual driver training and statewide Roadeo competition. It was "bookended" by bootcamp PASS and Defensive Driving training coordinated by Kaitlyn Richardson with UNK. Congratulations to all six drivers who earned the opportunity to travel to Palm Springs, CA in May to compete at the national Roadeo. It is so exciting to be able to provide six scholarships this year! Thank you to all who help organize and coordinate the Roadeo and volunteer to serve as judges. Also, a special thank you to all the transit managers who allow their drivers to participate. This has always been a premiere learning experience and we depend on you each year to help make it even better. If you have suggestions on how NATP can improve this event to make it even more beneficial, please contact us.

Jennifer and I hosted the NATP booth at the NACO Conference in Kearney December 12th and 13th. They had approximately 800 attendees from all across the state. It is always interesting how often we hear "Oh, we don't have public transit," only to find out that they do. They just don't recognize it until they associate it with the senior center or the "handibus" service. A quick history lesson on how many rural transit systems were originally created under the Older American Act often resolves their confusion. But it goes to show how much education still needs to be done to advocate for public transit as more than "just for elderly and disabled."

Later this week the NATP board will be meeting to schedule and plan various events for 2019, including Legislative Day, Public Transit Week, the Midwest state managers meeting to be held in Kansas City this year, and, of course, the 27th annual Roadeo. #### 2 YEAR FUNDING CYCLE FOR OPERATING ASSISTANCE

The funding for Section 5311 operating assistance has changed from a one-year cycle to two years. The next round of funding will cover fiscal years 2019-2020 and 2020-2021. This will reduce the administrative burden of an annual application cycle.

Applications are now available on your dashboard at nebraskatransit.com. The deadline for submittal of the application and all supporting documentation is March 1, 2019.

#### CHANGES IN THE NEBRASKA CHILD SAFETY RESTRAINT LAW

Effective January 1, 2019, federally funded vehicles need to be compatible with the new law LB 42, with the exception of the small buses. Because of the shoulder harness configuration, you cannot safely secure a booster seat in the vehicle. The Nebraska Department of Health and Human Services has reviewed the small bus restraints and seats. Since the buses have tether anchor points and lap only belts on the seats, they have suggested a supplemental harness/restraint system that would meet the requirements for the booster seat.

They have even suggested a manufacturer and specific device. The 86Y-Car cam distributed by Ez-On Products converts a lap belt into a 4-point securement suitable for a child restraint.

NATP will again coordinate a proclamation signing with Governor Ricketts. The proclamation will be in March, but the date has not been determined.



# NATP MEMBERS ATTEND 23RD NATIONAL CONFERENCE ON RURAL PUBLIC & INTERCITY BUS TRANSPORTATION

Breckenridge, Colorado, was the setting for this year's 23rd National Conference on Rural Public and Intercity Bus Transportation, held September 30 – October 3. The theme for this conference was "Changing Lives. Strengthening Communities." NATP Executive Director Jennifer Eurek attended the conference along with scholarship winners Nikki Pinkelman, Colleen Clayton, Scott Bartels, and Mitch Sump. Other NATP members Cindy Sanders, Denise Smith, and Beth Siegfried were able to make the trip. Kari Ruse and Bill Biven attended from NDOR.

The conference consisted of numerous workshops, breakout sessions, time with exhibitors and different entertainment options and meals. The leaves were just starting to turn which made such a wonderful view.

The conference started off on Sunday afternoon with an opening reception. This was a great opportunity to meet with other attendees from across the country, planning committee members, and exhibitors.

On Monday morning, the keynote speaker was Donna Griggs of Propel Change, who spoke on performance improvement and change management. Her theme was utilizing employees when making changes and teaching them how to maintain those changes. She spoke about minimizing turnover, increasing engagement, accountability, and productivity.

Following the keynote, attendees had the opportunity to attend three educational sessions. During lunch, several national awards and student paper awards were presented. After the last session for the day, an Expo reception was held with the vendors.

Tuesday featured different roundtable sessions, numerous breakouts, bus show luncheon, continuation of the vendor show and a special fiesta-themed evening event.

Wednesday morning capped the conference off with a "town hall" meeting and update from FTA.

#### STARTRAN NOW USING SIMULATOR FOR DRIVER TRAINING

StarTran is now using a new Bus Operator Simulator System that helps train new employees and strengthen skills for current operators. A grant from the Federal Transit Administration (FTA) Ladders of Opportunity Initiative funded 70 percent of the cost.

Transit Director Mike Davis said the system is an accurate representation of what a public transit driver may encounter. The system features a 330-degree virtual display with surround sound that mimics the experiences of operating a StarTran bus. The simulator features 60 driving scenarios that include navigating various types of streets, traffic devices, pedestrians, passenger noise and street conditions such as rain or snow.

"Safety is StarTran's first consideration in everything we do, and we continue to raise the bar on safety with new innovations," Davis said. "We appreciate the FTA's investment in our vision to be one of the safest modes of transportation and for giving us one more way to attract, train and retain best-in-class, professional operators."

#### NATIONAL CONFERENCE ON RURAL TRANSPORTATION

# Thank you to NATP for the scholarship to attend the National Conference in beautiful Breckenridge Colorado. The sessions were excellent and the networking with colleagues from

Breckenridge, Colorado. The sessions were excellent and the networking with colleagues from across the country was very valuable and useful in the day to day operation of Central City Public Transit system.

The Transit system in Colorado is unique in the way they connect from city to city with no charge to their riders. No charge per boarding because of the tourist trade. I also attended a session on how Public Transit plays a key role in our communities in the event of a disaster.

What should be documented during this time to possibility get reimbursement for the cost? In the state of Vermont because of the environment, they are changing to all electric Transit systems. The speaker shared they would have to recharge once a day and it would take 2 to 4 hours to recharge.

The round table sessions opened up my eyes on marketing your program to your community or county and working together with others to accomplish goals. The importance for all transit systems is providing the best and safest service for all of our riders every day.

There was a great representation of Transit managers and Department of Transportation from Nebraska, who all had a great time. On a personal note, I would like to thank Beth from McCook, for teaching me how to drive the mountains.

#### Colleen Clayton, Director of Merrick County Senior Services, Central City, NE

I was asked to write .up a small review of what I learned at the national conference. I learned that the difference between 9600 feet of elevation and 8500 feet of elevation (my previous high for an extended stay) doesn't sound like much until you actually experience it! LOL

In all seriousness though I attended a few sessions that I felt were beneficial. Most notable was the Safety for Rural & Tribal Transit Systems, Our Changing Workforce, and Strengthening Rural & Intercity Transit Service through Community Outreach. The first one, Safety, was held on Sunday and the lower number of attendees offered a large amount of discussion opportunities between the moderators and the group. Some concerns I have regarding service during inclement weather and rider

safety during inclement weather were addressed by the moderators and others in the group. I have slowly been trying a few of them with our recent bit of weather. Initial results are too small to project but the one that was well received by our regular riders was contacting them the evening before regarding their status for the next day. The second session regarding the workforce was helpful not so much from a "What Can We Do?" but at least let me know that others in similar transit systems are also experiencing issues that I am. Lancaster County has a very low unemployment rate and the majority of applicants I get are either not interested due to wages, etc. or are not suitable candidates. The final one of the three I felt was the most helpful focused on community outreach and marketing. Lancaster County is a bit different from some other transit areas in that over 90% of residents reside in the city of Lincoln so marketing in the smaller communities has been challenging. Add in the relatively close proximity of the smaller communities to Lincoln and the pool of potential riders is further diluted due to ease of getting rides from family and friends. It was at this session I met a couple of gentleman from Arizona who work with the White Sands Reservation and they offered some interesting ideas about how they marketed to non-native riders in the vicinity of the reservation.

All in all I felt the experience was worthwhile and was pleased I was able to attend, in spite of the altitude sickness!

# RURAL AND INTERCITY BUS TRANSPORTATION CONFERENCE

During the preconference on Sunday, I elected to take the tour of the Eisenhower-Johnson Memorial Tunnel. This is the highest vehicle tunnel in the world at an elevation of 11,155 feet on the West end. It took five years to construct and open the Eisenhower Tunnel which opened March 8, 1973. The Johnson Tunnel did not open until December 21, 1979. There are so many fascinating aspects involved in operating the 1.6 mile long tunnels that bore beneath the Continental Divide. Daily operations involve or require back up generators, a security team, surveillance monitors, traffic control communications, ventilation, towing units, and even its own fire department.

There were many great sessions offered at the conference. Some highlight topics for me were:

 How difficult change is and the importance of managing change to create improved performance
The importance of brand marketing and using

it to knock down negative perceptions and stigma associated with riding the bus

• Using website accessibility to enhance your brand and extend agency marketability

I did also come away with a substantial sense that technology is going to drive the opportunity for greatest performance improvement in rural transit.

One more item I would comment on is the terrific improvement that has been made for driver visibility on some twelve passenger model buses. Refer to the attached photo.
