### **Tools for the Manager's Toolbox**

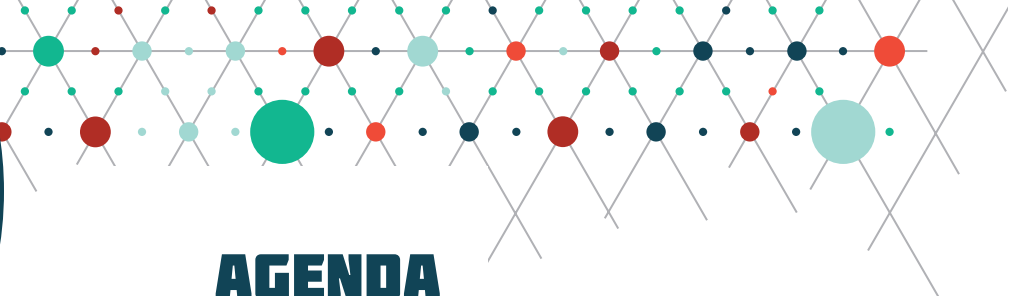
